BACKGROUND

Electron Technologies (Pty) Ltd was placed in business rescue in September 2019 due to a number of its major civil engineering clients being placed in business rescue, with little or no expectation of recovery of amounts owed by those companies to Electron.

The business rescue plan that was prepared and subsequently accepted by the creditors allowed for the repayment of creditors from its trading operations and any recoveries from the civil engineering companies in business rescue.

BUSINESS RESCUE PROGRESS

The matter with SARS, previously reported on, is ongoing. No appeal has been lodged. The amounts to be refunded have been determined by SARS as being the amounts set-off against the pre-business rescue debt. However, they keep on responding by saying that they have referred it to their legal department, who don't seem to react.

The matter with the client has been determined in a arbitration and awarded to Electron together with interest and costs. No appeal was made and despite letters of demand to their lawyer, they too are not responding. All steps and avenues open to Electron are being followed to recover this money so that it can be dealt with correctly

OPERATIONS

The company's post commencement business activities are continuing to improve and it is anticipated that this will continue. However, there are still certain restrictions on its operations due to its being in business rescue.
